RE: Report from the State Treasurer to the Joint Legislative Commission on Governmental Operations: Divestments Related to the Divestment From Companies Boycotting Israel Act of 2017

**Dear Commission Members:** 

The North Carolina Department of State Treasurer (the "Department") hereby submits its annual report pursuant to N.C. Gen. Stat. § 147-86.84 of the Divestment from Companies Boycotting Israel Act of 2017 (codified at N.C. Gen. Stat. §§ 147-86.80 to 147-86.84), as amended from time to time (the "Act").

The Act prohibits the North Carolina Retirement Systems or the Department from investing funds with a restricted company, which is a company engaging in a "boycott of Israel," as defined by the Act. N.C. Gen. Stat. §§ 147-86.80 and 147-86.81. In addition, State agencies, local government units, and other political subdivisions of the State are prohibited from contracting with restricted companies. N.C. Gen. Stat. § 147-86.82.

The Department hereby reports on the following:

- The updated divestment and do-not-contract lists; and
- A list of all investments sold, redeemed, divested, or withdrawn in the current reporting year.
- I. Companies Boycotting Israel Divestment and Do-Not-Contract Lists, as of August 30, 2018

Companies listed as a result of their own apparent activities related to boycotting Israel may be found on the "Final Divestment and Do-Not-Contract List—Restricted Companies Boycotting Israel," which is enclosed with this document.

For the above-listed companies, known parents and subsidiaries subject to the Act are also provided in a list attached to this report (see "Final Divestment and Do-Not-Contract List (Parents and Subsidiaries)—Restricted Companies Boycotting Israel").

#### II. Summary of Investments Sold, Redeemed, Divested, or Withdrawn

In the current annual reporting cycle, no investments have been sold, redeemed, divested, or withdrawn pursuant to the Act.

### FINAL DIVESTMENT AND DO-NOT-CONTRACT LIST— RESTRICTED COMPANIES BOYCOTTING ISRAEL

Compiled as of August 30, 2018 (revised October 2018)

Pursuant to N.C. Gen. Stat. § 147-86.81, the State Treasurer has determined that the following companies appear to be engaged in a "boycott of Israel," as that term is defined in the North Carolina Divestment From Companies Boycotting Israel Act of 2017 (the "Act"), based on other state lists, federal information, and other credible information.

The State Treasurer and North Carolina Retirement Systems may not invest funds, and must divest any existing investment, with the restricted companies listed below. N.C. Gen. Stat. § 147-86.81. In addition, restricted companies listed below are ineligible to contract with the State of North Carolina or any political subdivision of the State. N.C. Gen. Stat. § 147-86.82. Any existing contracts with the restricted companies listed below shall be allowed to expire in accordance with their terms. N.C. Gen. Stat. § 147-86.82(d).

The Department of State Treasurer is not responsible for compliance with the Act by other agencies or political subdivisions of the State of North Carolina. The Department's responsibilities are solely focused on implementing N.C. Gen. Stat. §147-86.81, which relates to the Department's investments, and implementing the Act as it relates to the identification of companies that appear to be engaged in a boycott of Israel.
