The North Carolina Department of State Treasurer (the "Department") hereby submits its annual report pursuant to N.C. Gen. Stat. § 147-86.45 of the Sudan (Darfur) Divestment Act of 2007 (codified at N.C. Gen. Stat. §§ 147-86.41 to 147-86.49), as amended from time to time (the "Act").

In addition to providing the updated list of companies that are subject to investment prohibitions and divestment (the "Final Divestment List"), this report provides an update regarding any investments that were sold, redeemed, divested, or withdrawn in compliance with the Act in the current reporting year.

I. Sudan Divestment Lists, as of August 30, 2018

Companies listed as a result of their own apparent activities in Sudan may be found on the "Final Divestment List—Sudan," which is enclosed with this document.

For the above-listed companies, known parents and subsidiaries subject to the Act are provided in a separate list enclosed with this document (see "Final Divestment List (Parents and Subsidiaries)—Sudan").

FINAL DIVESTMENT LIST—SUDAN

Compiled as of August 30, 2018 (revised October 2018)

Pursuant to N.C. Gen. Stat. § 147-86.43, the State Treasurer has determined that the companies listed below appear to be engaged in “restricted business operations,” as that term is defined in the Sudan (Darfur) Divestment Act of 2007 (the “Act”), based on other state lists of restricted companies, federal information, and other credible information.

The State Treasurer and North Carolina Retirement Systems may not invest funds, and must divest any existing investment, with the restricted companies listed below. N.C. Gen. Stat. § 147-86.44.

The Department of State Treasurer is not responsible for compliance with the Act by other agencies or political subdivisions of the State of North Carolina. The Department’s responsibilities are solely focused on implementing N.C. Gen. Stat. § 147-86.44, which relates to the Department’s investments, and implementing the Act as it relates to the identification of companies that appear to be engaged in restricted business operations in Sudan.
