PRC 0036 provides funding to charter schools based on ADM. Other allocations are included in the PRC 0036 allotment, such as School transportation, Children with Disabilities and others. The specific state grants included in PRC 0036 need to spend on the intended purpose and supported in the finance records.

I. PROGRAM OBJECTIVES

The objective of the PRC 0036 is to provide funding for Charter Schools.

II. PROGRAM PROCEDURES

PRC 0036 includes an allocation to the Charter Schools for funding based on PRC. Other state funding allocations are grouped with the 0036-allocation including:

- Charter School Transportation Grants (G.S. 115C-218.42)
- Other grants as applicable

(The schools have to support that they met objectives of the programs)

1. Activities Allowed or Unallowed
