Brief Description of Program:

I. PROGRAM OBJECTIVES

In accordance with North Carolina General Statutes 143B-820, State Subsidy to County Detention Facilities, the Section shall administer a State subsidy program to pay a county that provides juvenile detention services and meets State standards a certain per diem per juvenile. In general, this per diem should be fifty percent (50%) of the total cost of caring for a juvenile from within the county and one hundred percent (100%) of the total cost of caring for a juvenile from another county. Any county placing a juvenile in a detention facility in another county shall pay fifty percent (50%) of the total cost of caring for the juvenile to the Section. The per diem rate is set at \$244 per juvenile, per day.

II. PROGRAM PROCEDURES

Brief Description of Program:

Project C.A.R.E. (<u>Caregiver Alternatives to Running on Empty</u>) provides critical comprehensive support, including respite care vouchers, to vulnerable unpaid family caregivers of individuals living with Alzheimer's disease or other related dementia (ADRD). The program effectively reaches isolated rural and minority communities through culturally sensitive outreach strategies with a unique family-centered, in-home intervention. Project C.A.R.E. aims to minimize State expenses and maximize the family's potential to provide the most appropriate, high quality and cost-effective care in the least restrictive setting thus delaying or preventing the need for institutionalization.

Project C.A.R.E. contracts with six community-based organizations to provide care consultation services in all 100 counties. Family consultants collaborate closely with the sixteen Area Agencies on Aging (AAA) and the Family Caregiver Support Program. This relationship allows for available resources to be coordinated and leveraged for maximum impact. Family consultants provide support directly to caregivers of persons living with ADRD by:

- 1. Offering care consultation services: dementia-specific information, caregiver assessments and individualized care plans, caregiver education and connections to social support networks,
- 2. Linking families with available community resources to address unmet needs including local support groups, supportive services, entitlement programs and other community resources,
- 3. Partnering with each AAA through its Family Caregiver Support Program to provide outreach, training and education,
- 4. Providing caregivers consumer-directed respite care vouchers (\$500 each) whereby the caregiver decides who, when and where to hire help,
- 5. Providing training and assistance to AAAs and the community-at-large to increase capacity to assist persons with dementia and their families and
- 6. Enhancing partnerships with and among the various entities serving persons living with ADRD and assisting their care partners.

The total annual budget for Project C.A.R.E. is \$1,033,333. Six organizations are awarded funds to provide Project C.A.R.E. regionally and one entity to financially manage the respite voucher awards.

The goals of the Urgent Repair Program ("URP") are: 1) to alleviate housing conditions which pose an imminent threat to the life or safety of very low and low-income homeowners with special needs; and 2) to provide accessibility modifications and other repairs necessary to prevent displacement of very low and low-income homeowners with special needs, such as frail elderly and persons with disabilities. It is an objective of the URP to serve households with urgent repair needs which cannot be met through other state- or federally-funded housing assistance programs.

Program funds may be used for three purposes only: 1) "Hard costs" (materials, labor, etc.) associated with repairs or modifications of eligible dwelling units; 2) "program support" costs for activities ancillary to the rehabilitation work (inspections, work write-ups, cost estimates, etc.); and 3) "Administrative" costs for necessary and documented administrative costs. More specific definitions of these cost categories are provided in the Program Guidelines at section 2.1, "Eligible Uses of Funds" ("PG 2.1"). Definitions vary slightly by funding cycle.

Unless specifically funded for disaster assistance ("URP-D"), recipients must limit hard costs and soft cost to a maximum of \$15,000 per dwelling unit. Recipients may set more stringent limits, in their adopted Assistance Policies, than program limits.

Program support costs are limited, on a unit-by-unit basis, based on the amount of hard costs. Under URP94, that maximum was 10% of hard costs. Purpose: The Injury and Violence Prevention Branch (IVPB) mission is to promote and protect the health and well-being of all people in North Carolina by preventing injury and violence. As part of the overall mission to prevent sexual violence in North Carolina, the IVPB receives and administers federal funds for the Rape Prevention and Education (RPE) Program. Funds are awarded to local agencies and organizations to provide prevention-oriented education and training in local communities. Funds are awarded to the North Carolina Coalition against Sexual Assault (NCCASA) to provide training, technical assistance, and tools to support local agencies/organizations in their prevention activities.

The Rape Prevention and Education Program is administered by the Centers for Disease Control and Prevention (CDC). Federal legislation specifies the major areas of allowable activities that are aimed at preventing rape and sexual assault, and the CDC has set program priorities and provided guidance to all states and territories for implementing the program. CDC expects all RPE programs at both the state and local levels to use a public health approach; to undertake planning, including an assessment of community needs and assets; to perform program evaluation; and to focus on primary prevention – preventing initial sexual violence perpetration and victimization.

Brief Description of Program:

This grant supports enhanced surveillance capacity at the state level to prevent and eliminate childhood lead poisoning, and to use surveillance data to identify the highest risk areas and implement appropriate population-based interventions. Examples of such interventions include enforcement of housing and health codes and public and health care provider education campaigns. Data may also be used to designate areas as 'lead safe' and qualify applicants to apply for a universal blood lead testing waiver through Medicaid. Surveillance data is also used to evaluate the timeliness and efficacy of case management of children identified with high blood lead levels.

This grant was acquired through a competitive application process submitted through the grants.gov website. The Centers for Disease Control and Prevention (CDC) awarded North Carolina \$568,678 beginning September 30, 2024, for the fourth year of a five-year project period. This project is 100% federally funded and has no matching or maintenance of effort requirements. The one subrecipient, UNC Chapel Hill Institute for the Environment (\$115,695), was selected based on necessary technical skills (e.g., health education and grant coordination expertise) and was approved by the CDC through the application review process. The portion of the grant transferred to UNC is by contract reimbursement. Performance requirements and measures are communicated to the UNC through the contracting process. Deliverables are monitored by site visits and required reports. Grant awards may not be expended for research, medical care and treatment, or for environmental remediation of lead sources. Funds may be used only for reasonable program purposes, including personnel, travel, supplies, and services.

Brief Description of Program:

The Injury and Violence Prevention Branch (IVPB) mission is to promote and protect the health and wellbeing of all people in North Carolina by preventing injury and violence. In 2011 the Branch was awarded funding from the Centers for Disease Control and Prevention to implement the Core Violence and Injury Prevention Program (CORE VIPP).

The overall purpose of the program is to assist State Health Departments (SHDs) to build and/or maintain effective delivery systems for dissemination, implementation and evaluation of best practice programs and policies. This includes support for general capacity building of SHDs and their local partners, as well as strategy specific capacity building for the implementation of direct best practice interventions (older adult falls and child injury). In addition, this program supports SHDs in their efforts towards integration or the strategic alignment of resources for meaningful change.

Base Component (BASE): This component will provide support to SHDs to develop and strengthen their injury and violence prevention programs by increasing general capacity in key areas identified as core components of SHD injury and violence prevention programs. Additional focus will be placed on traumatic brain injury and falls prevention activities focused on seniors.

Regional Network Coordinating Organization (RNCO): Resources and capacity for injury and violence prevention and control are limited and vary by state. Systematic efforts are needed to share information and best practices and make it available to all potential users. A regional network of states encourages the creation, sharing and effective application of knowledge to address injury and violence prevention and control within all states. The purpose of the regional network coordinating organization is to collaborate across and between states to build capacity, share best practices and scientific evidence and increaseinjury and violence prevention capacity through the regional network to prevent and reduce injury and violence.

Enhance Supplement (ENHANCED): This component will provide support to community coalitions to build capacity through the implementation of public health actions to prevent injury in disproportionately affected communities. This supplemental funding will focus on providing training on community-level factors that reinforce Adverse Childhood Experiences, AKA ACES, as well as provide community coalitions with training and technical assistance to implement strategies that promote injury and violence prevention.

Brief Description of Program:

The purpose of the Healthy Beginnings Program is to fund projects in various communities to impact the reduction of minority infant mortality and preterm and low birthweight births to improve minority birth outcomes. Funds are given to local health departments and private non-profit organizations to support local community-based minority infant mortality reduction efforts.

In 1994, the North Carolina General Assembly appropriated \$750,000 annually to fund fifteen projects that would demonstrate means to lower infant mortality and low birth weight rates among minority populations. Funding decreased in 2001 to \$700,000 to fund 14 projects. In 2009, funds from the Targeted Infant Mortality Reduction Program (TIMR) were merged with Healthy Beginnings. In FY2024-2025, Healthy Beginnings received an additional \$129,830 in funding. The goal of the Healthy Beginnings Program is to address the two-fold plus disparity between white and minority infant mortality in the State of North Carolina by targeting areas with significant minority infant mortality. A community-based approach addressing infant mortality was mandated with a specific focus on the formulation and implementation of innovative strategies to improve birth outcomes and involvement from a variety of community organizations.

Community and faith-based organizations and local health departments with experience working in minority communities are eligible to apply for Healthy Beginnings funding.

Funded recipients are expected to implement programs that will impact the reduction of minority infant mortality and low birthweight births in their communities and thereby improve minority birth outcomes. Funding is available for 3 years, contingent upon the availability of funds and performance. In FY2024-2025 there are 10 sites funded at an award level of \$86,861 to \$92,983 annually.

The purpose of the Care Management for High-Risk Pregnancies Program (CMHRP) funding for Individuals Ineligible for Medicaid is to provide specialized prenatal and postpartum care management services to individuals who are pregnant, economically marginalized and ineligible for Medicaid. Brief Description of Program:

The Tobacco Prevention and Control Branch (TPCB) collaborates with and builds capacity of partners, including State and local agencies, local health departments and community organizations, to plan and implement culturally appropriate evidencebased strategies to reduce deaths and health problems due to tobacco use and secondhand smoke (SHS). TPCB's four major goal areas are to: 1) Eliminate exposure to SHS, 2) Promote tobacco use cessation among adults and youth, 3) Prevent initiation of tobacco use among youth and young adults, and 4) Identify and eliminate tobacco-related disparities.

CDC funds must be used for focused strategies to change systems, develop and implement policies, change the environment in which tobacco use occurs, and impact population groups rather than individuals. Other appropriate uses of funding include:

If a local health department has other sources of tobacco prevention and control support, the health department may not use CDC money to duplicate funding for the same activities or supplant existing funds. Some health departments may be required to include indirect costs in their budgets.

The local health department must have on site the Potential Conflict of Interest and Disclosure Form regarding acceptance of funds from tobacco-related entities and the Health Department Tobacco Use Policy. Any changes in these policies must be reported to the TPCB.

Brief Description of Program:

The Family Violence Prevention and Services Program administers the Family Violence Prevention and Services Act (FVPSA), the primary federal funding stream dedicated to the support of emergency shelter and related assistance for victims of domestic violence and their children.

FVPSA Core is a primary federal grant funding stream for local domestic violence programs to provide core services, including crisis response, safe housing, advocacy, counseling, legal assistance, safety planning, and comprehensive support.

Specifically, FVPSA Core's statutory purposes per 42 U.S.C. § 10401(b) are to:

(1) assist States and Indian tribes in efforts to increase public awareness about, and primary and secondary prevention of, family violence, domestic violence, and dating violence; and

(2) assist States and Indian tribes in efforts to provide immediate shelter and supportive services for victims of family violence, domestic violence, or dating violence, and their dependents.

The federal cognizant agency is the U.S. Department of Health and Human Services Administration for Children and Families. The NC Council for Women and Youth Involvement applies for North Carolina's formula allocation through an annual application process.

The federal funds are allocated to sub-grant recipients (non-profit and governmental entities) based on a funding formula that assesses population data, number of people served, and fiscal and programmatic grant compliance. The award process includes a grant application review and compliance assessment prior to formal award notification being sent to sub-grant recipients.

Funds are disbursed based on a reimbursement process once each sub-grant recipient completes and enters into a contract agreement with the NC Council for Women and Youth Involvement. The contract period varies depending on the funding stream.

All grant awards are contingent upon the NC Council for Women and Youth Involvement receiving the specified grant funds from the U.S. Department of Health and Human Services. Eligible applicants that become grantees are required to submit monthly reimbursement reports and semiannual statistical reports that provide accountability for the Family Violence Prevention and Services Act funds.

Use of funds is covered by 42 U.S.C. § 10408(b):

(1) Funds awarded to eligible entities under subsection (a) shall be used to provide shelter, supportive services, or prevention services to adult and youth victims of family violence, domestic violence, or dating violence, and their dependents, which may include—

- (A) provision, on a regular basis, of immediate shelter and related supportive services to adult and youth victims of family violence, domestic violence, or dating violence, and their dependents, including paying for the operating and administrative expenses of the facilities for such shelter;
- (B) assistance in developing safety plans, and supporting efforts of victims of family violence, domestic violence, or dating violence to make decisions related to their ongoing safety and well-being;
- (C) provision of individual and group counseling, peer support groups, and referral to community-based services to assist family violence, domestic violence, and dating violence victims, and their dependents, in recovering from the effects of the violence;
- (D) provision of services, training, technical assistance, and outreach to increase awareness of family violence, domestic violence, and dating violence and increase the accessibility of family violence, domestic violence, and dating violence services;
- (E) provision of culturally and linguistically appropriate services;
- (F) provision of services for children exposed to family violence, domestic violence, or dating violence, including age-appropriate counseling, supportive services, and services for the non-abusing parent that support that parent's role as a caregiver, which may, as appropriate, include services that work with the non-abusing parent and child together;
- (G) provision of advocacy, case management services, and information and referral services, concerning issues related to family violence, domestic violence, or dating violence intervention and prevention, including—

(i) assistance in accessing related Federal and State financial assistance programs;

(ii) legal advocacy to assist victims and their dependents;

(iii) medical advocacy, including provision of referrals for appropriate health care services (including mental health, alcohol, and drug abuse treatment), but which shall not include reimbursement for any health care services;

(iv) assistance locating and securing safe and affordable permanent housing and homelessness prevention services;

(v) provision of transportation, childcare, respite care, job training and employment services, financial literacy services and education, financial planning, and related economic empowerment services; and

(vi) parenting and other educational services for victims and their dependents; and

(H) prevention services, including outreach to underserved populations.

Grant funds provided under FVPSA cannot be used for direct payments to any client/victim or dependent of a client/victim. Federal funds made available to a State or Indian tribe under this program shall be used to supplement and not supplant other Federal, State, tribal, and local public funds expended to provide services and activities that promote the objectives of this program.

All existing FVPSA Core grantees are eligible for additional FVPSA ARPA Supplemental funds to continue efforts to prepare, prevent, and respond to COVID-19. Within those parameters, grantees have flexibility to determine which services best support the needs of children and families experiencing family violence, domestic violence, and dating violence. These funds are available through September 2025.

ARPA allocated funding to the Secretary of Health and Human Services to detect, diagnose, trace, monitor, and mitigate COVID-19. In July 2021, the Secretary authorized FVPSA to receive a portion of that funding to assist states, territories, and tribes with providing access to COVID-29 testing and vaccines for domestic violence shelters and programs. The purpose of these funds is to prevent, prepare for, and respond to COVID-19 with an intentional focus on increasing support for domestic violence survivors. Within those parameters, grantees have flexibility to determine which services best support the needs of survivors, children, and families experiencing family violence, domestic violence, and dating violence. These funds are available through September 2025.

The Consolidated Appropriations Act of 2023 included disaster recovery funds for FVPSA federal award recipients to provide temporary housing and assistance for domestic violence survivors including alteration, renovation, and construction of damaged or destroyed property and facilities following Hurricanes Fiona and Ian. These funds remain available through September 2027.

Brief Description of Program:

The General Assembly of the State of North Carolina authorizes funding to certain Visitor Centers (NCGS 20-79.7(c)(2) revised) located within rest area sites or at stand-alone sites, for the purpose of providing visitor information to the traveling public. The Visitor Center Agreements specify the activities allowed and unallowed Funding may only be used for allowable operational costs and in accordance with the cost principles and uniform administrative requirements defined in the OMB Uniform Guidance, 2 CFR 200, and/or state policies. Each Visitor Center Funding agreement specifies the activities allowed to be funded under the program.

The program is administered by the North Carolina Department of Transportation, hereinafter referred to as the Department. Brief Description of Program:

The purpose of the Infant Mortality in Communities now known as the Reducing Infant Mortality in Communities (RIMC) program is to provide funds to local health departments to implement evidence-based programs in the counties that have experienced the highest infant mortality disparity ratios and infant mortality rates during the five-year period of 2016-2020.

In the state fiscal year 2015-2016, the North Carolina General Assembly appropriated one million five hundred and seventy-five thousand dollars (\$1,575,000) in the Maternal and Child Health Block Grant Plan to the Department of Health and Human Services' (DHHS) Division of Public Health (DPH) for each year of the 2015-2017 fiscal biennium to be used for evidence-based programs in North Carolina counties with the highest infant mortality rates. These funds continue to be re-appropriated.

Local health departments are required to implement at least two evidence-based strategies that are proven to lower infant mortality rates. The evidence-based strategies are the following: breastfeeding support services, Centering Pregnancy model of group prenatal care, doula services, infant safe sleep services; and preconception and interconception health services. The selected strategies have all proven to be an effective means to improve birth outcomes through addressing pregnancy intendedness, preterm birth, and/or infant death.

Funding is available for 3 years, contingent upon the availability of funds and performance. In FY2024-2025, there are 8 local health departments funded at an award level of \$152,307 to \$253,302.

Brief Description of Program:

The Bicycle Helmet Initiative provides helmets to eligible government and non-profit organizations in an effort to reduce head-related injuries to children while riding their bicycles. Helmets are awarded and distributed once per calendar year in the spring and awardees have the remainder of the calendar year to host their helmet distribution event, which emphasizes bicycle safety practices through education. A committee reviews and determines if applicants are eligible to receive helmets. Priority is given to organizations that try to distribute helmets to low-income children, who are the most vulnerable to head-related injuries from bicycles. The applicants are required to file a report about the distribution event within 30 days after the event occurs or at the end of the year.

The Integrated Mobility Division will solicit bids from helmet vendors every 3 years. One vendor will be selected. The helmet vendor is required to ship helmets directly to the recipients after IMD has made award selections. Organizations are required to have a commercial address in order to receive the shipment of helmets. PO boxes and residential address are not allowed by vendors. The vendor is responsible for sending the correct number of helmets and correlating sizes to each awarded organization.

The Injury and Violence Prevention Branch (IVPB) mission is to promote and protect the health and well-being of all people in North Carolina by preventing injury and violence. In 2023 the Branch was awarded funding from the Centers for Disease Control and Prevention to implement the Overdose Data to Action in States (OD2A-S) cooperative agreement.

The purpose of this funding is to integrate an interdisciplinary and cohesive approach to advance and evaluate comprehensive state-level interventions for preventing prescription drug overuse, misuse, abuse, and overdose, as well as improve the timeliness of fatal and nonfatal opioid overdose surveillance. It builds on previous CDC funding opportunities: Prescription Drug Overdose Prevention for States and Enhanced State Surveillance of Opioid-Involved Morbidity and Mortality, and Overdose Data to Action. Interventions of priority address drivers of the prescription drug overdose epidemic, particularly the misuse and inappropriate prescribing of opioid pain relievers. Priorities include prevention strategies to improve safe prescribing practices and prevent prescription drug overuse, misuse, abuse, and overdose; as well increasing the timeliness and dissemination of fatal and nonfatal opioid overdose and associated risk factor reporting to key stakeholders. The priority strategies are:

- 1. Enhance and maximize a state PDMP (Prescription Drug Monitoring Program).
- 2. Implement community or insurer/health system interventions aimed at preventing prescription drug overdose and abuse.
- 3. Conduct policy evaluations.

- 4. Develop and implement Rapid Response Projects.
- 5. Increase the timeliness and dissemination of aggregate fatal and nonfatal opioid overdose and associated risk factor

reporting.

Brief Description of Program:

ConCPT Program funding consists of two (2) categories of: Consolidation and Coordination of Public Transportation (ConCPT) services.

Financial assistance is provided to public transportation providers to support the consolidation of two or more transit systems into a single transit system to maximize resources, gain efficiencies, and increase access to public transportation is categorically a Consolidation Grant. Eligible applicants must be subrecipients of Federal transit funds through the NCDOT Integrated Mobility Division or directly from the Federal Transit Administration. The ConCPT Consolidation funds are to be used for new consolidation projects. Eligibility and eligibility requirements are published in IMD's procedures and the annual call for projects. General public transportation activities in rural North Carolina (areas outside urbanized area boundaries) are the focus of this funding. ConCPT Consolidation funds must be directly applied to public transportation projects and cannot be used to offset local funding. The funds may be used for administrative and/or operating expenses. The application must clearly specify the use of funds. The consolidation requirements and amount of potential funding are described in the annual call for projects and the program application.

Financial assistance is provided to public transit systems to assist in coordinating trips between three or more transit systems for long-distance routes that run every weekday on a fixed route with a published schedule. The coordination efforts established with this program are designed to maximize resources, gain efficiencies, and improve access to public transportation. FVPSA Core is a primary federal grant funding stream for local domestic violence programs to provide core services, including crisis response, safe housing, advocacy, counseling, legal assistance, safety planning, and comprehensive support.

Specifically, FVPSA Core's statutory purposes per 42 U.S.C. § 10401(b) are to:

(1) assist States and Indian tribes in efforts to increase public awareness about, and primary and secondary prevention of, family violence, domestic violence, and dating violence; and

(2) assist States and Indian tribes in efforts to provide immediate shelter and supportive services for victims of family violence, domestic violence, or dating violence, and their dependents.

The federal cognizant agency is the U.S. Department of Health and Human Services Administration for Children and Families. The NC Council for Women and Youth Involvement applies for North Carolina's formula allocation through an annual application process.

The federal funds are allocated to sub-grant recipients (non-profit and governmental entities) based on a funding formula that assesses population data, number of people served, and fiscal and programmatic grant compliance. The award process includes a

grant application review and compliance assessment prior to formal award notification being sent to sub-grant recipients.

Funds are disbursed based on a reimbursement process once each sub-grant recipient completes and enters into a contract agreement with the NC Council for Women and Youth Involvement. The two-year contract period runs from October 1st through September 30th.

All grant awards are contingent upon the NC Council for Women and Youth Involvement receiving the specified grant funds from the U.S. Department of Health and Human Services. Eligible applicants that become grantees are required to submit monthly reimbursement reports and semi-annual statistical reports that provide accountability for the Family Violence Prevention and Services Act funds.

Use of funds is covered by 42 U.S.C. § 10408(b):

(1) Funds awarded to eligible entities under subsection (a) shall be used to provide shelter, supportive services, or prevention services to adult and youth victims of family violence, domestic violence, or dating violence, and their dependents, which may include—

(A) provision, on a regular basis, of immediate shelter and related supportive services to adult and youth victims of family violence, domestic violence, or dating violence, and their dependents, including paying for the operating and administrative expenses of the facilities for such shelter;

(B) assistance in developing safety plans, and supporting efforts of victims of family violence, domestic violence, or dating violence to make decisions related to their ongoing safety and well-being;

(C) provision of individual and group counseling, peer support groups, and referral to community-based services to assist family violence, domestic violence, and dating violence victims, and their dependents, in recovering from the effects of the violence;

(D) provision of services, training, technical assistance, and outreach to increase awareness of family violence, domestic violence, and dating violence and increase the accessibility of family violence, domestic violence, and dating violence services;

(E) provision of culturally and linguistically appropriate services;

(F) provision of services for children exposed to family violence, domestic violence, or dating violence, including age-appropriate counseling, supportive services, and services for the non-abusing parent that support that parent's role as a caregiver, which may, as appropriate, include services that work with the non-abusing parent and child together;

(G) provision of advocacy, case management services, and information and referral services, concerning issues related to family violence, domestic violence, or dating violence intervention and prevention, including—

(i) assistance in accessing related Federal and State financial assistance programs;

(ii) legal advocacy to assist victims and their dependents;

(iii) medical advocacy, including provision of referrals for appropriate health care services (including mental health, alcohol, and drug abuse treatment), but which shall not include reimbursement for any health care services;

(iv) assistance locating and securing safe and affordable permanent housing and homelessness prevention services;

(v) provision of transportation, childcare, respite care, job training and employment services, financial literacy services and education, financial planning, and related economic empowerment services; and

(vi) parenting and other educational services for victims and their dependents; and

(H) prevention services, including outreach to underserved populations.

Grant funds provided under FVPSA cannot be used for direct payments to any client/victim or dependent of a client/victim. Federal funds made available to a State or Indian tribe under this program shall be used to supplement and not supplant other Federal, State, tribal, and local public funds expended to provide services and activities that promote the objectives of this program.

With the passage of ARPA, FVPSA received an historic investment for rape crisis centers and sexual assault programs to support sexual assault survivors impacted by COVID-19. The purposes of ARPA Sexual Assault grants are: 1) to assist with the transition to virtual services for rape crisis centers and sexual assault programs that provide crisis and support services and assistance to sexual assault survivors; and 2) to support the increased emergency needs of sexual assault survivors because of COVID-19. These grants provide flexibility in how recipients use the funding to support a range of activities, including but not limited to counseling, mobile advocacy, telehealth, teletherapy, peer support, temporary housing, rental assistance, supplies, equipment, and software.
